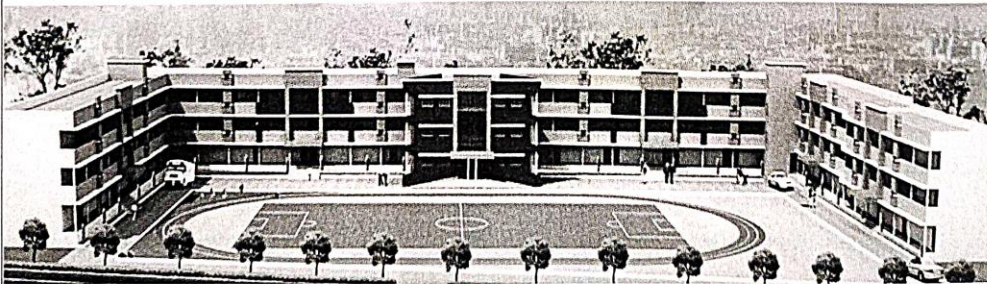

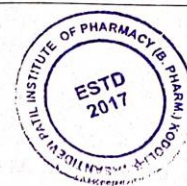

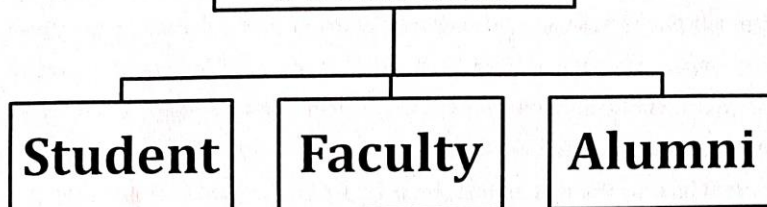

## FEEDBACK ANALYSIS REPORT

### Student Feedback Analysis:

Institute takes student feedback regarding teaching learning process, twice every semester. i.e. after 15 days of commencement of semester and at the end of semester. Those feedbacks of faculties showing poor performance are asked to improve their performance by increasing the use of ICT tools and student centric methods. Institute also takes feedback about facilities, infra and human resources at every end of semester. From the feedback analysis it's found institute is up to mark with all these points.

### Faculty Feedback Analysis:

The faculty feedback related to curriculum enrichment, curriculum delivery, academic ambiance, management policies, etc. is also collected and analyzed. As per analysis more than 75% faculties response showing that that curriculum is not bridging the gap between academics and industry. The same is reported to Principal through the IQAC department. For the next coming academic year more interaction with industrial persons through organization of guest lectures, seminar and conferences, industrial visits both on site and virtual, industrial certification programs are planned.

### Alumni Feedback Analysis:
