## Consulting Agreement

This Consulting Agreement, dated effective 01<sup>st</sup> October, 2022 (this "Agreement"), is made and entered into by and among YSPMS's Vasantidevi Patil Institute of Pharmacy, Kodoli (the "Consultant") and Jain Pharmaceuticals, Pune (the "Company") on the basis of earlier done Memorandum of Understanding on dated 05th September 2020 duly signed in presence of stakeholders of both the parties.

WHEREAS, the Company is engaged in research, development and commercialization of certain pharmaceutical products and wished to engage CONSULTANT to advise COMPANY on matters relating to the field of pharmaceutical related pre-clinical trials, product development (small scale), testing of products and compensation of work order as per mutual consent (hereinafter "Field") under the following terms and conditions:

### ARTICLE 1 SCOPE OF WORK

1. **Services:** The Company has engaged Consultant to provide services in connection with the Company's developing, manufacturing and research activities related to pharmaceutical products. Consultant will provide time to time based consultancy as per required from the Company in terms of research, clinical testing, product development and manufacturing aids which shall be timely completed and such other services as and when intimated (collectively, the "consulting services").
2. **Time and Availability:** Consultant will devote fixed hours per month or as per company requirements in performing the services for the Company as stated herein. Consultant shall have discretion in selecting the dates and times it performs such consulting services throughout the month giving due regard to the needs of the Company's business. The Services may be performed via telephone and other forms of communication, and may include meetings with personnel and other consultants at times and locations to be mutually agreed upon as and when necessary. In each instance, CONSULTANT shall perform the Services only upon COMPANY's request and after the scope of the Services has been approved by COMPANY.
3. **Confidentiality:** In order for Consultant to perform the consulting services, it may be necessary for the Company to provide Consultant with Confidential Information regarding the Company's business and products for proper understanding of the job order and to execute the same. The Company will rely heavily upon Consultant's integrity and prudent judgment to use this information only in the best interests of the Company.
4. **Standard of Conduct:** In rendering consulting services under this Agreement, Consultant shall conform to high professional standards of work and business ethics. Consultant shall not use time, materials, or equipment of the Company without the prior written consent of the Company. In no event shall Consultant take any action or accept any assistance or engage in any activity that would result in any university, governmental body, research institute or other person, entity, or organization acquiring any rights of any nature in the results of work performed by or for the Company.
5. **Outside Services:** Consultant shall not use the service of any other person, entity, or organization in the performance of Consultant's duties without the prior written consent of an officer of the Company.

6. **Reports:** Consultant shall periodically provide the Company with written reports of his or her observations and conclusions regarding the consulting services. Upon the termination of this Agreement, Consultant shall, upon the request of Company, prepare a final report of Consultant's activities. Also Company shall each time provide a certificate of the work done after successful completion of the consultancy.

### ARTICLE 2 COMPENSATION FOR CONSULTING SERVICES

1. Compensation. In consideration for CONSULTANT's services hereunder, COMPANY shall pay CONSULTANT as follows: i) Upon successful completion of the work allocated or ii) If the consignment given is huge partial payment for initiation of work shall be done and later upon completion as per mutual consent.

### ARTICLE 3 TERM AND TERMINATION

- 1 This Agreement shall be effective as of 01<sup>st</sup> October, 2022 till 01<sup>st</sup> September 2023 and shall continue in full force and effect for 01 year (12 consecutive months). The Company and Consultant may negotiate to extend the term of this Agreement and the terms and conditions under which the relationship shall continue. This Agreement may be extended by written agreement signed by the parties.
- 2 Responsibility upon Termination. Any equipment provided by the Company to the Consultant in connection with or furtherance of Consultant's services under this Agreement, including, but not limited to, computers, laptops, and personal management tools, shall, immediately upon the termination of this Agreement, be returned to the Company.

### ARTICLE 4 CONFIDENTIAL INFORMATION

#### PROPRIETOR

1. **Obligation of Confidentiality:** In performing consulting services under this Agreement, Consultant may be exposed to and will be required to use certain "Confidential Information" (as hereinafter defined) of the Company. Consultant agrees that Consultant will not and Consultant's employees, agents, or representatives will not use, directly or indirectly, such Confidential Information for the benefit of any person, entity, or organization other than the Company, or disclose such Confidential Information without the written authorization of the President of the Company, either during or after the term of this Agreement, for as long as such information retains the characteristics of Confidential Information.
2. **Definition:** "Confidential Information" means information not generally known and proprietary to the Company or to a third party for whom the Company is performing work, including, without limitation, information concerning any patents or trade secrets, confidential or secret designs, processes, formulae, source codes, plans, devices or material, research and development, proprietary software, analysis, techniques, materials, or designs (whether or not patented or patentable), directly or indirectly useful in any aspect of the business of the Company, any vendor names, customer and supplier lists, databases, management systems and sales and marketing plans of the Company, any confidential secret development or research work of the Company, or any other confidential information or proprietary aspects of the business of the Company. All





information which Consultant acquires or becomes acquainted with during the period of this Agreement, whether developed by Consultant or by others, which Consultant has a reasonable basis to believe to be Confidential Information, or which is treated by the Company as being Confidential Information, shall be presumed to be Confidential Information.

- 3. **Publications:** CONSULTANT shall not solely publish, nor submit for publication, any work directly arising out of the provision of the Services provided hereunder without prior written approval from COMPANY.
- 4. **Intellectual Property:** Title to all inventions and discoveries made jointly by CONSULTANT and COMPANY resulting from the Services provided hereunder shall be owned jointly by the CONSULTANT and COMPANY. Inventorship shall be determined in accordance with applicable Patent law. In the performance of the Services hereunder, CONSULTANT shall also comply with COMPANY's policies when on COMPANY premises.
- 5. **Modification:** No modification, termination, or attempted waiver of this Agreement, or any provision thereof, shall be valid unless in writing signed by the party against whom the same is sought to be enforced.
- 6. **Waiver of Breach:** The waiver by a party of a breach of any provision of this Agreement by the other party shall not operate or be construed as a waiver of any other or subsequent breach by the party in breach.
- 7. **Entire Agreement:** This Agreement contains the entire understanding of the parties with respect to the matters herein contained and supersedes all previous agreements and undertakings with respect thereto. This agreement may be modified only by written agreement signed by the parties.
- 8. **No Conflict:** Consultant warrants that Consultant has not previously assumed any obligations inconsistent with those undertaken by Consultant under this Agreement.

## MEMORANDUM OF UNDERSTANDING

And

VASANTIDEVI PATIL INSTITUTE OF PHARMACY, KODOLI the second party, and represented herein by Dr. Santosh A. Payghan, Principal, Vasantidevi Patil Institute of Pharmacy, Kodoli (hereinafter referred to as "Second Party", organization which expression, unless excluded by or repugnant to the subject or context shall include its successors in office, administrators and assigns)

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party') as

### WHEREAS:

- A) First Party is a Pharmaceutical Company named: GFam Pharmaceuticals, Kodoli.
- B) GFam Pharmaceuticals, Kodoli & Vasantidevi Patil Institute of Pharmacy, Kodoli, believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The party's intent to cooperate and focus their efforts on cooperation within area of Training, Placement and Entrepreneurship.
- D) Both parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.
- E) The second party is an educational institution belonging to the people, working for the people and being administered by the people.
- F) The second party is promoted by Dr. Santosh A. Payghan, Principal whose office and head office of second party is situated at Kodoli, Tal- Panhala, Dist- Kolhapur.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

### CLAUSE 1 CO-OPERATION

- 1.1 Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institute and its related wings. The parties shall

keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

- 1.2 First party and Second Party co-operation will facilitate effective utilization of the resources and facilities for collaborative activities and Training and Placement.
- 1.3 The general terms of co-operation shall be governed by this MoU. The parties shall cooperate with each other, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MoU. The term of Definite Documents, this MoU shall represent the entire understanding as to the subject matter here of and shall supersede any prior understanding between the Parties on the subject matter hereof.

### CLAUSE 2 SCOPE OF THE MOU

- 2.1 The budding graduates from the institutions could play a key role in economic development of the country through Training and Entrepreneurship. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.2 **Curriculum Design:** First Party will give valuable inputs to the Second Party in designing teaching / training methodology and suitably customize the curriculum so that the student fit into the current Pharmaceutical scenario meaningfully.
- 2.3 **Industrial Training & Visits:** Industrial training bridges the gap in academic and in the Industry. It helps students and faculties to learn new technology, stay them updated with market demand, making them aware of new discoveries and develop skills and competencies required to become employable. The training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to Industrial career. The Second Party will provide its resources & training for the hands-on training of the learners enrolled with the First Party.
- 2.4 **Placements:** First Party to offer placement opportunities for the student of Second Party through campus / In-plant Interviews.
- 2.5 Both parties to obtain all internal approvals, consents, permissions, and licenses of what so ever nature required for offering the programmers on the terms specified herein.
- 2.6 There is no financial commitment on the part of, the first party to take up any programme mentioned in the MoU, if there is any financial consideration, it will be dealt separately.

### CLAUSE 3 INTELLECTUAL PROPERTY

Nothing contained in the MoU shall, by express grant, implication, estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other party.

### CLAUSE 4 VALIDITY

- 4.1 This agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period the First Party, as the case may be, will take effective steps for implementation of this MoU. Any act on the part of the Second Party after termination of this Agreements by way of communication, correspondence etc., shall not be construed as an extension of this MoU.
- 4.2 Both parties may terminate this MoU upon 30 calendar days' notice in writing. In the event of termination, both parties have to discharge their obligations.

### CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES

- 5.1 It is expressly agreed that Party I and Party II are acting under this MoU as independent contractors, and the relationship established under this MoU shall not be construed as a partnership. Neither party is authorized to use the other party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other party, neither party shall have, nor represent itself as having, any authority under the terms of this MoU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's, or to extend credit on behalf of the other party.

Any divergence or difference derived from the interpretation or application of the MoU shall resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District Head Quarters of the First Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of Kolhapur.

5. The parties may nominate an identified individual to establish a "Joint Working Group" to manage and execute the cooperative activities mentioned in this MoU.



